

### DEVELOPMENT Public Policy

MSCOD partners with the MN Dept Public Safety/ Division of Homeland Security and Emergency Management, the MN Board on Aging, the MN Dept of Health, and the UofM Institute for Community Integration, emergency response organizations and our other state disability agency partners to develop public policy standards for local and municipal emergency management plans that include a disability-focused approach.
